Please note that passengers riding Routes 11, 52, 59, 97, and 98 will board and deboard at the sheltered bus stop on 34th Street North. A pedestrian gate is located along the fence and a sidewalk connection is available from the sheltered bus stop to the PSTA lobby.

ANY LAST MINUTE POSTPONEMENT OF THIS MEETING WILL RESULT IN ANOTHER SCHEDULED MEETING SCHEDULED AT LEAST TWO DAYS AFTER THE POSTPONED MEETING.

VISITORS DRIVING TO PSTA MUST ENTER THE COMPLEX THROUGH THE SCHERER DRIVE ENTRANCE AND MAY PARK JUST SOUTH OF THE ADMINISTRATION BUILDING.

PLEASE NOTE THAT THE SCHERER DRIVE FACILITY IS NOW SERVED BY ROUTES 11, 52, 59, 97 AND 98 (THE LAST TWO ARE COMMUTER ROUTES) AND WILL BOARD AND DEBOARD AT THE SHELTERED BUS STOP ON 34TH STREET NORTH. A PEDESTRIAN GATE IS LOCATED ALONG THE FENCE AND A SIDEWALK CONNECTION IS AVAILABLE FROM THE SHELTERED BUS STOP TO THE PSTA LOBBY. ROUTE 98 ALSO SERVES THE SHELTER IN FRONT OF PSTA ON SCHERER DRIVE.
