These cities are not members of the Transit Authority (Treasure Island and St. Pete Beach receive service via a contract). \*\* The terms shown above refer to those as set forth in the State Statute (i.e., three year terms, with the exception of some members who joined the Board as a result of legislation passed in 2006 whose initial terms were shorter than three years). The Cities of Tarpon Springs, Safety Harbor, and Oldsmar have an interlocal agreement regarding Authority membership. Each city appoints a member for a three-year period. The City of Tarpon Springs appointed one for the period October 1, 2017 through September 30, 2020. The City of Safety Harbor will appoint a member for the period October 1, 2020 through September 30, 2023. The City of Oldsmar will appoint one for the period October 1, 2023 through September 30, 2026. **Oldsmar finished Tarpon Springs term ending September 30, 2020.**

\*\*\* These appointments 'may not be an elected official,' according to the legislation. All other appointees are to be elected officials. <sup>1</sup> Appointments to the PSTA Board are limited to three (3) consecutive terms.
